NOTIFICATION FOR MIGRATION OF INTERNSHIP FROM OTHER UNIVERSITY/INSTITUTE /COLLEGE TO ALL INDIA INSTITUTE OF AYURVEDA (AIIA), GOA

- Duly completed application are invited for the migration from other universities/institutes
  /colleges to All India Institute of Ayurveda (AIIA), Goa for urban internship of six months
  for 50 seats after passing the BAMS course from the Universities/Institutes /Govt/private
  colleges duly recognized by the NCISM.
- Applicant has to submit the NOC and Character certificate from the college (attended for completing the BAMS course duly signed by the competent authority.) as well as they have to obtain NOC form AIIA, Goa.
- Migration will be allowed subject to availability of the seats. The seat will be allotted on first come first basis. The final decision regarding the acceptance or rejection of the migration application, as well as the issuance of a No Objection Certificate (NOC), will be whole discretion the Director of AIIA. Obtaining all necessary permissions, provisional registration, character certificate and NOC is the sole responsibility of the student applying for the migration of the internship. AIIA will not be responsible for any procedural delay.
- Candidates doing internship on migration from other Universities/Institutes /Govt/private colleges shall not be entitled for stipend. However, AIIA, Goa will forward attendance of the student to their parent institute of migrated internee based on which stipend if applicable may be given by the parent institute of the student with their own discretion and the policy.

- Candidates are required to send the completely filled application form with self-attested copies of all required documents through Speed/Registered Post to the Director, All India Institute of Ayurveda (AIIA), Village-Dhargalim, Taluka-Pernem, North Goa, Goa-403513. Candidates are also instructed to send the completely filled application through Emailaiiagoaoffice@gmail.com.
- Upon receipt of the application in the prescribed format and after subsequent scrutiny, candidates will be notified via email in case of their selection for the internship at AIIA, Goa.
- Student from other University/Institute/College has to pay the prescribed fees as below.

Caution deposit: Rs. 10000/

(Refundable on successful completion of 6 months rotatory internship)

Fees for the internship: Rs. 20000/- (Fees for Six Months)

(Non- refundable to be paid fully at the time of internship transfer)

Grand Total: Rs. 30000/-

Note: In case the candidate is fail to complete the six months internship, in such case, the caution money of Rs. 10000/- is liable to be forfeited and will not be refunded.
