Travelling fare will be reimbursed only at the end of the program and subject to eligibility limited maximum up to 2 tier A.C. rail fare as per the laid down conditions & principles. Production of ORIGINAL TICKETS is mandatory as per the instructions of the Ayurveda Scheme, Ministry of Ayush.2. Train tickets must be booked from windows of Railways either from the IRCTC website/Mobile app, or Balmer and Lawrie or Ashoka Travels. Tickets booked through other mobile apps or websites will not be considered for reimbursement. Please note that TATKAL or DYNAMIC PRICING train tickets will not be reimbursed.3. On production of original bills of food not exceeding to Rs. 300/- will be paid for the journey period. No food expenses will be paid if the journey is made by Shatabdi/ Rajdhani/ Duranto trains.4. Reimbursement towards the journey performed by road will be permissible for the places which are not connected by rail. The road mileage will be limited to 2 AC rail charges or actual claim, whichever is lower.5. Arrangements for accommodation and food will be provided by the Institute during the CME period within the budget limits of the CME.6.
